

IUCN Workplan - 2002

Introduction

The IUCN Workplan for 2002 builds on the 2001 workplan, and draws strategic guidance from the IUCN Programme as approved during the 2nd World Conservation Congress in Amman. The 2001 Workplan, as presented to Council in February 2001, was organised both by component programme and Key Result Area (KRA), providing detail concerning the contribution of component programmes to each individual quadrennial result with the overall IUCN Programme. This document accurately reflected both the breadth and complexity of the IUCN Programme, as well as projected results and activities for 2001.

The IUCN Council welcomed the presentation of this detailed workplan, particularly as it reflected for the first time the organization of the new IUCN Programme. The Programme Coordination Team is acutely aware, however, of the large volume of information the workplan entails. As a result, and building on efforts already invested in this area during 2001, a great deal of effort is being invested in the development of the IUCN programme database — the Programme Information Management System (PIMS). The PIMS database will allow users to review the overall IUCN workplan by key results from individual programmes or across programmes in a user-friendly virtual environment. Moreover, PIMS will be capable of generating reports based on a variety of criteria, such as programme or geographic criteria, KRA, KEGO, theme, or any combination thereof as requested by the user.

In future, it is expected that the IUCN annual workplan will be distributed electronically to Council, either by CD-ROM or directly via on-line access to the database itself. A narrative summary, of course, will be provided, focusing on major programme highlights and drawing out analysis across programmes. The primary advantage of this approach will be the availability of the entire IUCN work programme accessible and searchable from a variety of perspectives and at varying degrees of detail. Council members will be able to obtain an overview of the entirety of the IUCN Programme, or alternatively "drill down" to any particular aspect of the programme, whether geographic, result based, or thematic, which may be of particular interest. Moreover, it will no longer be necessary to distribute lengthy reports in advance of Council meetings, which is both a costly and environmentally dubious practice.


In addition to the above, a summary report providing an overview and analysis of the workplan was recommended by Council. In response to this request, a summary overview of each KRA is provided in this document. Finally, please note that at the time of preparation of this report the financial data coded by individual result and KRA was not available for the Asia Programme. Moreover, the table of results for the Environmental Law Programme was also not available. Consequently, please note that in the graphic summaries presented within the summary narrative sections for each Key Result Area data related to the Environmental Law Programme and Asia has not been included.

Key Result Area 1: Effective Management and Restoration of Ecosystems

Many of the results accruing from the work undertaken by the Ecosystems and Sustainable Livelihoods group will be achieved within this Key Result Area. As a result, this will continue to be a major area of investment within the IUCN Programme. The Wetlands and Water Programme has recently concluded a contract with the Dutch Government for initial financing for the Water and Nature Initiative (WANI). Implementation will begin in 2002, in conjunction with our regional offices in Mesoamerica, Asia, East, Southern and Central Africa, as well as Europe.

The Commission on Ecosystem Management will focus on developing its membership to enhance the Union's technical capacity to understand and manage the spectrum of ecosystems embraced in the IUCN programme. Effort will be made to link the network membership to the various initiatives and activities pursued by the Ecosystem and Sustainable Livelihoods Group.

Within the regional programmes, work will continue on putting the Mesoamerican biological corridor concept into practice. In addition, the regional ECONET programme in Europe will be moving forward, wherein IUCN experts are working closely with government and member partners in the establishment of a regional network of



ecological areas. Major sub-regional initiatives in ecosystem conservation in Asia include the Mekong River Basin as well as Coastal and Marine management and poverty alleviation in South Asia. Major new and ongoing initiatives in Eastern Africa include the Jakarta Mandate for conservation of the Western Indian Ocean, support for the Nile perch fishery in Lake Victoria (phase II), and the Regional Wetlands Programme for Eastern Africa. Concomitantly, a series of new wetlands and water conservation projects will get under way in a number of our regional offices as WANI begins implementation during 2002.

The Forest Programme will continue with development of the conceptual framework and methodologies for implementation of the landscape approach to forest conservation at field level. Within the Protected Areas Programme, increasing focus and energy within the 2002 workplan will be devoted to the organisation of the 2003 World Parks Congress. This is a critical global event both for the PPA as well as for IUCN as a whole.

The Ecosystems and Sustainable Livelihoods Group, comprising the Species, Ecosystem (Forest Conservation, Wetlands and Water, Marine and Emerging Ecosystems) and Protected Areas Programmes will provide the secretariat focal points for SSC, CEM, CEESP, and WCPA. They will provide technical and, where possible, financial support to Regional Programmes and develop projects that provide financial support for the units located in the Policy, Biodiversity and International Agreements Group.

One of their key roles will be to generate and disseminate cross-sectoral knowledge on the conservation and sustainable/equitable use of species and ecosystems, particularly in relation to underlying causes of ecosystem decline. In addition, the group will work with field projects operated by Regions and Commissions to test and demonstrate practical approaches for biodiversity conservation and sustainable livelihoods, to build capacity of key actors in the use of these approaches, and to support and influence the development of good governance, agreements, processes and policies.

The Heads of the individual cost centres grouped under Ecosystems and Sustainable Livelihoods will continue to be responsible for sectoral policies that are directly related to their programmes (e.g. CITES, IWC, WHC, UNFF, RAMSAR etc). They will work in close collaboration with the Policy, Biodiversity and International Agreements Group in relation to the multilateral environmental policies (CBD, FCCD, FCCC etc) and other international and cross sectoral policies such as those related to globalisation, financial flows, and trade.



Key Result Area 2: Institutions, agreements, processes and policies

The functional grouping of programme units within the Secretariat, in addition to the reorganisation of others, will result in much more focused and coordinated work being undertaken under this Key Result Area than has been possible over the past year. By incorporating the Environmental Law Programme and the existing biodiversity and climate change related policy work of the BPCD, the new Biodiversity Policy and International Agreements group will coordinate IUCN's input to all global policy processes as these relate to the IUCN Programme. In addition, this group will also act as a

clearinghouse for information on all IUCN programme related policies for both global and sectoral policy work undertaken throughout the Secretariat.

In regard to KRA 2, our policy work will continue to focus on the CBD, FCCC, CCD, as well as the WTO and WSSD. Both regional and thematic programmes will be placing greater emphasis on delivering




the biodiversity message in the context of economic development and the environment, particularly in areas such as agriculture, mining, tourism and freshwater resources.

Within the Environmental Law Programme, greater emphasis will be placed on addressing aspects of a number of international conventions and legal instruments which have not received a great deal of attention in the past. These include issues related to biosafety, alien species, and access and benefit sharing under the CBD, various international accords for the conservation of marine species, and the Aarhus Convention to name but a few. The Species Programme will continue to provide technical expertise and input into the implementation of the CBD, CITES, Ramsar, and CMS. Highlights in this area include coordination of a likely 5th meeting of the African Elephant Range States Dialogue and ongoing work related to the conservation of migratory species, such as marine turtles.

In addition to the Species Programme, sectoral policy work will also be carried out by other global thematic programmes. The Forest Programme will maintain its ongoing working relationship with the

World Bank in the refinement of its forest policy, as well as continue playing a prominent role within the UN Framework on Forests (UNFF) process. The Water and Wetland Programme will continue to provide expert input into the Ramsar process, as well as a number of regional water conservation dialogues.

Within the Secretariat's overall policy delivery system coordinated by the Biodiversity Policy and International Agreements group, our offices in the US



and Europe also play a vital role for the Secretariat in the successful delivery of results under this

KRA. It is envisioned that the European Regional Office of IUCN will soon shift to Brussels, a move which will greatly enhance IUCN's ability to influence and participate in a variety of European and pan-European environmental policy fora. In Washington, our US office will continue to provide a vital link into multilateral organizations based in the United States which play a major role in international environmental governance.



information and support on biodiversity business related activities and investments.





Key Result Area 4: Equitable sharing of the costs and benefits

As noted above, equity issues in the realm of conservation and natural resource use are often at the source of ecosystem mismanagement and environmental decline. No where is this more evident, perhaps, than in the challenge of managing protected areas in developing regions of the world where poverty is endemic and where large numbers of people depend on the exploitation of natural resources for basic subsistence and survival needs. The 2003 World Parks Congress, for which most of the planning will be taking place in 2002, will focus on "Benefits Beyond Boundaries" as its central theme. The need to fully integrate protected areas into regional planning processes, and in particular national development plans, is seen as critical in ensuring the relevance of protected

areas as an effective conservation approach in the 21st century.



Two of the four working groups formed under the Commission on Environmental, Economic and Social Policy (CEESP) will important roles addressing this key result area. Members of the Working Groups Collaborative on Management and Sustainable Livelihoods are engaged in developing and implementing pilot field projects in several regions to highlight best practices and promote more

equitable relationships in between rural people and protected areas (collaborative management) and in income derived from uses of wild renewable resources. The Commission is collaborating with the SSC Sturgeon Specialist Group to develop more accountable and effective management regimes for sturgeon in the Caspian Sea.

Within socio-economics in general, a wide variety of work is currently ongoing in this field. A number of institutions, along with IUCN, are planning a collaborative effort in 2002 called the "Alliance for Change" to address global gender issues. It is expected that the Secretariat's ground-breaking efforts on coordinating experience and sharing lessons learned within the context of the involvement of indigenous and local peoples in conservation will continue into 2002 and beyond. As with coordination on gender issues in conservation, outposted to our regional office in Central America, the programme activities with respect to indigenous peoples will also be outposted to one of our regional offices (SUR). The Sustainable Use Initiative will also continue to be active within this KRA, and is the process of developing a revised strategy over the next 3 years.



the Wetlands and Water Conservation Programme, and the Species Programme, provide the major contributions to this Key Result Area. Working in collaboration with regional programmes, ecologically oriented assessments, such as in the area of forests and wetlands, have already begun and will continue during 2002. Many species related assessments are also ongoing, with others beginning in 2002 as well. Particular emphasis will be in the area of freshwater fishes and amphibian species, along with marine turtles. Moreover, much of the species related assessment work carried out in 2002 in all areas will be focused on the preparation and launch of the 2003 Red List of Endangered Species. Many of the Secretariat regional programmes will be directly involved in data collection related to the Red Listing process, in addition to participating in other data collection exercises coordinated through other thematic programmes.

Key Result Area 5: Assessment of biodiversity and of related social and aconomic factors

While KRA 5 addresses the collection of biodiversity and socio-economic information related to the generation of knowledge for the conservation of nature and sustainable use of natural resources, Key Result Area 6 focuses on the efficient management and use of this information as well as ensuring effective communication both within and outside of our normal constituency.


The recent restructuring of the Union's communication-related units aims to enable an improved capacity to address KRA 6 through the integration of programmatic and corporate communication needs. The Communication group now includes the Information Management Group, IUCN's web site management, Publications, the Commission on Education and Communication secretariat focal point and corporate communication staff.

With respect to information management, an overall strategic development and fundraising strategy for e-IUCN – The Green Web is currently being developed. Within this strategy, the IUCN Knowledge Network is being upgraded and the Programme Information Management System (PIMS) is currently being put in place within the Knowledge Network. Both will be pillars of the new e-IUCN system. Individual component programmes such as Forests, Wetlands, and Species, as noted above, are spearheading initiatives for the collection of biodiversity and conservation related data. The World Conservation e-Atlas will incorporate and store this data in an effective, geographically based information retrieval system that will be at the disposal of the Union and our world-wide constituency of partners organizations.

Basic investments in upgrading our hardware and other capabilities will also be implemented during 2002 including investments in regional programmes as required, particularly in the area of improving communication connectivity. Major upcoming events (e.g. WSSD, WPC) will also assist in stimulating these developments as well as improving our overall presence on the web. A major new

initiative with the Canadian International Development Agency, concentrating on knowledge management and sharing between the two institutions, will also be developed during 2002.

With respect to communications, there has been a widely expressed need to more effectively focus IUCN's approach to the use of the web as a tool for the implementation of the IUCN Programme, particularly with



respect to increasing and improving our visibility. Our web site will be used to capitalize on major global events like the CBD CoP, WSSD and WPC to communicate the Union's position on issues, stimulate interest in a variety of issues, and promote the Union. A major new initiative with the Canadian International Development Agency, concentrating on knowledge management and sharing between the two institutions, will also be launched.

This fund will support three to five cross-sectoral, interdisciplinary initiatives, involving Commissions, regional offices, and global thematic programmes to address strategic issues decided by the Director General on the advice of Programme and Policy Committee of Council, Directors of Global Programme and Corporate Strategy, and the Programme and Policy Group.
