Dear Professor Zakri,

In response to your letter dated 30 October 2013, I write to reiterate IUCN's strong interest and support for IPBES. This is based on our many years of scientific work and our wish to offer our expertise in designing and developing tools and methodologies that we feel will support the Platform.

IUCN is delighted to see the considerable progress made by IPBES over the past few months since its official establishment at the Panama meeting in April 2012. We consider that the draft work programme 2014-2018 is realistically ambitious and has identified priority activities based on the four functions of IPBES. We particularly welcome the strong place given to regional activities, which will allow participation of a wide range of stakeholders.

Mandated by our Members at our World Conservation Congress in 2012, IUCN is ready to contribute to the implementation of the IPBES work programme by establishing a strategic relationship with the Platform, based on the strong alignment between our respective programmes. The current IUCN Programme 2013-2016 and the draft IPBES Programme 2014-2018 show numerous areas for synergies, most notably through the provision of information and data from the IUCN Red List of Threatened Species, the Key Biodiversity Areas and the IUCN Red List of Ecosystems. The IUCN Commissions can also contribute to the Platform's work, in view of the expertise of their large volunteer networks.

IUCN is therefore ready to provide support to the implementation of the Platform's work through the following:

- facilitated access to IUCN data and information contained in the IUCN Knowledge Products, including tailored analyses and publications;
- design and development of policy tools and methodologies;
- implementation of capacity-building projects;
- participation of the IUCN Commissions in the development of regional/sub regional networks to assist in assessments and capacity-building;
- in-kind technical support through one professional (full time equivalent) staff member every year engaging on relevant activities including global, regional, thematic, general or methodological assessments, communication, outreach and stakeholder engagement;

 hosting meetings in IUCN offices throughout the world (excluding travel and DSA for participants).

Following your request, you will find in the attached form a financial estimation of these in-kind contributions encompassed in our commitment. More details may be provided once the IPBES work programme is adopted and the procedure for identifying and engaging strategic partnerships has been agreed.

Once again, I reiterate IUCN's availability to work with IPBES and we look forward to a successful outcome from the meeting in Antalya.
